

**OFFER OF MOLODYI LIS LLC ON CONCLUDING AN AGREEMENT ON THE PROVISION OF SERVICES BY SPORTS AND GAMING ENTERTAINMENT COMPLEX "SEIKLAR" ADVENTURE AND FAMILY LEISURE ROPE PARK IN THE TERRITORY OF THE "PARTYZANSKAYA SLAVA" REGIONAL LANDSCAPE PARK IN DARNYTSKYI DISTRICT OF KYIV CITY**

For the purposes of this offer, the following terms are used in the following meanings:

Offer (proposal to conclude an agreement) means this document posted on the information stands of the ticket offices of the "SEIKLAR" Adventure and Family Leisure Rope Park and/or on the Internet at: [www.seiklar.com.ua](http://www.seiklar.com.ua)

Offer acceptance means full and unconditional acceptance by the Customer (Client, Visitor) of the conditions set forth in the Offer by 100% prepayment of the cost of the Contractor's services in respect of which the Agreement is concluded.

Customer (Visitor) means a person who has accepted the Offer and is a consumer of the Contractor's services under the concluded Agreement, as well as other persons (children, minors), who are the consumers of the Contractor's services under the concluded Agreement, which are accompanied by the Customer.

Contractor: MOLODYI LIS LIMITED LIABILITY COMPANY (EDRPOU code: 35912200, legal address: 03028, Kyiv city, Nauky Prospect 30).

Agreement means an agreement between the Customer and the Contractor on the provision of services of the "SEIKLAR" Adventure and Family Leisure Rope Park, which is concluded by acceptance of the offer by the Customer to conclude an Agreement (offer).

"SEIKLAR" Adventure and Family Leisure Rope Park (hereinafter referred to as the rope park/the Complex) means the territory, routes (trails, courses) and Rope Park facilities located on the territory of the "PARTYZANSKA SLAVA" regional landscape park in the Darnytskyi district of Kyiv city.

Entrance ticket (ticket) means a document on the right to visit the Rope Park for a period limited by the Rules of visiting the Rope Park.

Rules for visiting the Rope Park on the territory of "PARTYZANSKAYA SLAVA" regional landscape park in the Darnytskyi district of Kyiv city mean the mandatory rules approved by the Contractor for the provision of Rope Park services, which are an integral part of the Offer, which are posted on the information stands of the Rope Park and/or on the Internet at: [www.seiklar.com.ua](http://www.seiklar.com.ua), which apply to all citizens (customers, visitors, clients, consumers) using the services of the Rope Park, as well as persons located on the territory of the Rope Park (Annex 1).

Safety rules for the Sports and Gaming Entertainment Complex "SEIKLAR" Adventure and Family Leisure Rope Park in the territory of the "Partyzanskaya Slava" regional landscape park in Darnytskyi district of Kyiv city mean mandatory safety rules approved by the Contractor during the passage of the rope trails of the Sports and Gaming Entertainment Complex "SEIKLAR" Adventure Rope Park (hereinafter referred to as the Adventure Trail), which is an integral part of the Offer, are posted on the information stands of the rope park and/or on the on the Internet at: [www.seiklar.com.ua](http://www.seiklar.com.ua), which apply to all citizens (customers, visitors, clients, consumers) using the services of the Rope Park, as well as persons located on the territory of the Rope Park (Annex 2).

Rules for visiting the playground of the Rope Park mean mandatory rules for Visitors approved by the Contractor, which are an integral part of the Offer, are posted on the information stands of the rope park and/or on the on the Internet at: [www.seiklar.com.ua](http://www.seiklar.com.ua), which apply to all citizens (customers, visitors, clients, consumers) using the services of the playground of the Rope Park, as well as persons located on the territory of the Rope Park (Annex 3).

The conditions for using the Adventure Park when completing the rope routes "UNIVERSAL", "PROFESSIONAL", "SUPER PROFESSIONAL", "SEIKLAR", "MAXIMUM" mean the mandatory rules approved by the Contractor for the provision of Rope Park services, which is an integral part of the Offer, which apply to all citizens (customers, visitors, clients, consumers) using the services of the Rope Park, as well as persons located on the territory of the Rope Park (Annex 4).

The conditions for using the Adventure Park when passing the rope routes "BABY", "TEENAGER" mean the mandatory rules approved by the Contractor for the provision of Rope Park services, which is an integral part of the Offer, which apply to all citizens

(customers, visitors, clients, consumers) using the services of the Rope Park, as well as persons located on the territory of the Rope Park (Annex 5).

1.1. The subject of this Offer is to provide the Customer with services related to the right to visit the Rope Park (hereinafter referred to as the Services) in accordance with the Rules for visiting the Rope Park.

1.2. The Customer undertakes to accept and pay for services in accordance with the terms of the Offer.

1.3. Upon termination of use of the services, the Customer agrees to return to the Contractor special safety equipment, is issued in an amount corresponding to the number of accompanying persons + 1 (for the Customer) after payment of the cost of services. In case of damage or loss of special safety equipment, the Customer shall reimburse the Contractor for the cost of the damage caused according to the current price list for damages of the Contractor.

1.4. A prerequisite for the provision of services in accordance with the Offer is the observance by the Customer and the persons accompanying the Customer of the Rules for visiting the Rope Park, the Safety Rules, the Terms of Use of the Rope Park, as well as the passage of the Customer and the persons accompanied by the Customer with preliminary oral safety instruction in order to obtain basic skills in safe passage of the routes (paths) of the Rope Park and in order to bring the necessary and reliable information about the potentially dangerous and harmful properties of services that could further adversely affect the health of the Customer.

The passage of the Rope Park routes by minors under the age of 18 years is carried out only accompanied by an adult accompanying the child (father, mother, other legal representative or other adult accompanying child on the territory of the Rope Park), who is fully responsible for the consequences of the child visiting the Rope Park. Admission to the starting area of the Rope Park of an accompanying person is carried out on a paid entrance ticket.

Adult persons accompanying the child (father, mother, other legal representative or other adult accompanying the child in the territory of the Rope Park) independently determine the physical ability of the child to use the Rope Park services and are fully responsible for the legality of the child's access to the Park, for the consequences of using the Park's services

by such a child and for the child's compliance with all requirements, rules, instructions, instructions of instructors.

Adult persons accompanying the child (father, mother, other legal representative or other adult accompanying the child in the territory of the Rope Park) are obliged to explain to the child all the Terms and Conditions, provide the necessary assistance to the child when following the routes (rope trails), visually control the ascent/descent and moving of the child along the route (rope trail), as well as to follow the child along the route (rope trail), constantly assist the child while following the route, and immediately assist the child in hanging (fall) of the child on the route, if it is difficult to use or the child is unable to use special safety equipment - immediately stop using the service (get off the route), using recommendations and the instructor's directions.

1.5. The cost of the Contractor's services is determined in accordance with the prices of the Contractor indicated on the information stand of the ticket offices of the Rope Park in accordance with the current price list of the Contractor. Payment for the Contractor's services is made in UAH in advance payment by depositing cash in the cashier of the Contractor. If there is a technical possibility, it is allowed to pay for services by bank transfer using plastic cards, the Customer can check directly with the cashier for payment for the availability of such an opportunity and the terms of payment using plastic cards.

1.6. The Contractor reserves the right to amend the conditions of the Offer or withdraw the Offer at any time at its discretion.

1.7. The Contractor provides the Customer with services only upon the acceptance of the Offer in accordance with the terms of this Offer, in an amount corresponding to the amount of services paid by the Customer. Services paid by the Customer are valid during the current day of payment for services (within the working hours of the Rope Park) and are not transferred to the next day and / or other time.

1.8. Without prejudice to the conditions of the Offer, the Customer and the Contractor have the right at any time to draw up a separate Service Agreement in the form of a bilateral written document.

1.9. The parties agreed that the fact that the Customer provided an entrance ticket to the Rope Park and the use (activation) of an entrance ticket by the Customer is a confirmation of the provision of services under this Agreement.

1.10. An integral part of this Offer is the Rules for visiting the Rope Park, which regulate the rules for the provision of services of the Park, the rules and conditions for the efficient and safe use by the Customer of the services of the Park, containing complete and reliable information about the services and other conditions for the provision of services of the Park.

**RULES FOR VISITING THE ROPE PARK IN THE TERRITORY OF THE  
"PARTYZANSKAYA SLAVA" REGIONAL LANDSCAPE PARK IN  
DARNYTSKYI DISTRICT OF KYIV CITY**

1. The right to visit the playground and/or rope trails of the Sports and gaming entertainment complex "SEIKLAR" Adventure Rope Park" (hereinafter referred to as the Adventure Trail) is granted only after purchasing an entrance ticket and/or other document that entitles you to the Adventure Trail. Entrance ticket can be bought only on the day of visiting the Complex.

2. Before purchasing an entrance ticket, the Visitors are required to familiarize themselves with the Rules for visiting the playground and the Adventure Trail.

3. The purchase of an entrance ticket is a confirmation that a Visitor is acquainted with these Rules and fully agrees with them.

4. After purchasing an entrance ticket to the playground and/or for passing the Adventure Trail, each Visitor is obliged to adhere to these Rules, safety precautions, and also to keep clean the territory of the Sports and gaming entertainment complex "SEIKLAR" Adventure Rope Park" (hereinafter referred to as the Complex).

5. The Visitors must be at least 120 cm tall, weighing no more than 110 kg to visit the Adventure Trail (except for "Baby" trail - from 2.5 years old).

6. Persons under the age of 18 (minors) can use the Adventure Trail only with the consent of the parents or a Visitor, who has all rights and permissions from parents/guardians to accept these Rules and is responsible for the life and health of minors in full, as well as for the material damage caused by them to the Adventure Park.

7. A Visitor shall be close to minors while they are passing the Adventure Trail on the "Baby" and "Teenager" routes. A Visitor is obligated to monitor and ensure that minors with him properly comply with all safety requirements, conditions and instructions of the employees of the Adventure Park.

8. The passage of other Adventure Trails by minors (except for the "Baby" and "Teenager" routes) occurs only with an adult. At the same time, the Visitor must be on the Adventure Trail with minors (one adult can accompany no more than 2 minors), and undertakes to

monitor and ensure that minors who are with him properly comply with all safety requirements, conditions and instructions of the employees of the Adventure Park.

9. Prior to visiting the Adventure Trail, a Visitor shall make sure that the chosen rope course matches his physical abilities, health and skills.

10. The beginning of a visit to the Adventure Trail is considered to be the moment of putting on a special fall arrest system.

11. The end of a visit to the Adventure Trail is considered the moment the special fall arrest system is returned to the employee of the Complex.

12. A Visitor and minors accompanied by him may use the Adventure Trail only after receiving detailed instructions and a system for the safe use of the Trail provided by an employee of the Complex.

13. The passage of the Complex is possible only in a special fall arrest system.

14. The passage of the Complex without a special fall arrest system, which must be fixed to the safety line, is prohibited and is dangerous to life and health.

15. Transfer of a special fall arrest system to another person is prohibited. Upon exiting the Adventure Trail, the special fall arrest system should be immediately returned to an employee of the Complex. A Visitor and the minors accompanied by him are obliged to use the Adventure Trail and the special fall arrest system carefully, not to break it or otherwise damage, to compensate MOLODYI LIS LLC for any damage caused by damage to the Adventure Trail and/or special fall arrest system as a result of their negligent or intentional action.

16. In case of loss or damage to the property of the Complex and/or the special fall arrest system as a result of negligent or intentional actions of a Visitor and/or the person accompanied by him, a Visitor is obliged to compensate for the losses incurred within the time period established by the administration of the Complex, as well as be liable for other violations committed by him , in accordance with applicable law.

17. Passage of rope courses of the Complex with an employee of MOLODYI LIS LLC (hereinafter referred to as the Instructor) is carried out upon payment of the corresponding service.

18. A Visitor is informed that when ordering the Instructor for the Adventure Trail along with the minor and/or a Visitor, the Instructor can only guide. In this case, the use of the Adventure Trail is under the responsibility of a Visitor. In this case, an adult agrees to ensure the safety of minors during passage of the Adventure Trail.

19. The payment is not refundable in case of refusal of a Visitor to complete the passage of the rope trails of the chosen rope course of the Complex after the beginning of its passage.

20. During the passage of the Adventure Trail, a Visitor is obliged to strictly follow the instructions of the Instructor and comply with all safety requirements, as well as guides and signs located on the rope trails.

21. A Visitor has been informed that visiting the Adventure Trail may be hazardous to the life and health of a Visitor.

22. A visit to the Complex is under the responsibility of a Visitor, and the administration of the Complex is not responsible for possible damage caused to a Visitor (including damage to health and property) if the damage is caused by non-compliance by a Visitor with the Rules, safety requirements and/or negligence of a Visitor when visiting the Complex.

23. A Visitor is aware that visiting the Complex may cause damage to clothing and his items. The Administration of the Complex is not responsible for the loss, damage or destruction of clothing and other things of a Visitor, including things left unattended.

24. Employees of the Complex are entitled to immediately withdraw a Visitor from the rope trail if a Visitor violates the Rules and/or safety requirements, does not comply with the orders of the Complex employees, or if visiting the Adventure Trail, in the opinion of the Complex employees, has become dangerous (in case of changing weather conditions etc.).

25. A Visitor must immediately leave the rope trails of the Complex in case of deterioration of his health.



26. The administration of the Complex reserves the right to terminate the operation of the Complex at any time for objective reasons (weather conditions, etc.), as well as in the event of force majeure.

27. The Complex will be closed during rain, thunderstorm and/or wind more than 10 m/s. The Visitors are required to leave the rope trails ahead of schedule under the supervision of the Instructor.

28. The fee paid to MOLODYI LIS LLC for using the Adventure Trail is returned to a Visitor only if the use of the Adventure Trail was not possible due to circumstances dependent on MOLODYI LIS LLC. In the cases specified in clauses 19; 24 - 27 of the Rules of visiting, funds paid by a Visitor are not refunded.

**PASSAGE OF THE ROPE COURSES OF THE COMPLEX IS AVAILABLE TO EVERYONE WITH THE EXCEPTION OF PERSONS:**

- with cardiovascular and neurological diseases
- with mental diseases, as this can be dangerous for themselves and for others;
- with spine disorders and musculoskeletal system disorders;
- with any health disorders that may worsen during the passage of the Adventure Trail, and with the exception of pregnant women;
- in a state of alcoholic, narcotic and/or other intoxication, as well as those that take drugs with a depressing effect on the central nervous system;
- the state and/or abilities of which, in the opinion of the employees of the Complex, do not allow to safely pass the rope trails of the Complex;
- whose behavior interferes with the rest of other Visitors of the Complex. Failure to comply with the rules of visiting the Complex or attempting to interfere with other Visitors is the reason for removing a Visitor from the Complex. In addition, Visitors who violate these Rules may be denied the right to visit the Complex again.

The staff of the Complex is authorized to take measures against Visitors who are in a state of alcoholic, narcotic and/or other intoxication, mentally unstable Visitors, as well as those Visitors who do not respond to comments from staff and do not adhere to these Rules.

If a Visitor violates the Rules and is forced to leave the Complex, payment is not refunded.

## **LIMITATIONS WHEN VISITING THE SPORTS AND GAMING ENTERTAINMENT COMPLEX**

Persons under the age of 18 (minors) are allowed to pass the Adventure Trail only with the consent of their parents, and/or a person who has all rights and permissions from parents/guardians to accept the Terms of Use of the Adventure Park and is responsible for the life and health of minors in full.

- Clothing should be comfortable and not restrict movement.
- Long hair should be brushed (braided, fastened hair, etc.).
- It is not allowed to be on the rope trails in shoes that easily fall off the feet (flip flops, sandals without straps, etc.).
- It is not allowed to take out sharp, long and voluminous objects: (bags, backpacks, umbrellas, etc.), as well as animals, on the Adventure Trails.
- It is not allowed to use the Complex in adverse weather conditions (thunderstorm, fog, wind more than 10 m/s, etc.).

## **IT IS PROHIBITED TO:**

1. Pass the rope trails of the Complex by Visitors in the state of alcohol, drugs and/or other intoxication, as well as under the influence of drugs or psychotropic drugs.
2. Pass the rope trails of the Complex without a special fall arrest system and appropriate instruction.
3. Pass the rope trails of the Complex in clothes that can catch on game elements, and in shoes, which is not fixed on the foot (flip flops, etc.) or in shoes with high heels.
4. Be on any element of the rope trail (platforms, ladders, game elements, etc.) without a safety accessory.
5. Pass rope trails by the minors independently (except for “Baby” and “Teenager” routes). Minors can pass the rope trails only with an adult, and a Visitor must be on the Adventure Trail with minors and must observe and ensure that minors comply with safety requirements, conditions and instructions of employees of the Adventure Park.
6. Deliberately swing on the ropes, other game elements of the rope trail, affect by any action the serviceability of the elements of the Complex and the special fall arrest system.
7. Take hands with the wire rope on which the descent is carried out.
8. Start the descent while the previous participant is in the “outer zone” of the descent - that is, a Visitor must wait until the previous participant at the finish of the descent comes off the grid (platform). Only then you can a Visitor begin the descent.
9. Begin passing the playing area before the end of its passage by the previous participant.
10. Interfere and/or create by own actions an obstacle/threat to the safety of other Visitors.
11. Throw any objects on the ground from a height, as well as take food, smoke while passing the rope trails of the Complex.
12. Give the special fall arrest system to third parties. Use, put on, remove, unfasten a special fall arrest system without the consent and instructions of the Instructor.
13. Independently change the order of passage of rope trails.
14. Go beyond the Complex in a special fall arrest system, or take it outside the Complex.
15. Use the Complex for other purposes.

16. Make fire on the territory of the Complex.
17. Bring alcoholic drinks with you and consume them. Discard rubbish, smoke (smoking is allowed in a designated place) and leave cigarette butts, bring and leave glass dishes.
18. Walk pets on the territory of the Complex.
19. Use the Complex by Visitors with cardiovascular diseases, persons with pacemakers, nervous disorders, musculoskeletal disorders, pregnant women, visitors with any health problems that may worsen while using the Complex, as well as those who are afraid of heights.

## **WORKING HOURS**

The Adventure and Family Leisure Rope Park is open from 10:00 every day.

**SAFETY REGULATIONS FOR THE SPORTS AND GAMING ENTERTAINMENT COMPLEX "SEIKLAR" ADVENTURE AND FAMILY LEISURE ROPE PARK IN THE TERRITORY OF THE "PARTYZANSKAYA SLAVA" REGIONAL LANDSCAPE PARK IN DARNYTSKYI DISTRICT OF KYIV CITY**

A special fall arrest system is a system for keeping the Visitors out of the Sports and gaming entertainment complex "SEIKLAR" Adventure Rope Park" (hereinafter referred to as the Complex). Malfunctions in the operation of this system are impossible and unacceptable, since safety depends on its reliability and no-failure operation. A special fall arrest system works with at least five-time safety margin and all parts of the safety chain consist of certified reliable elements. The special fall arrest system consists of:

**1. A carabiner with an automatic coupler is a device for attaching any equipment elements to each other.**



The carabiner has a tensile strength of at least 2200 kg in the longitudinal direction and 600 kg in the transverse direction. At all stages, Visitors should monitor the proper use of carabiners, namely, to ensure that loads are not applied to the hook (coupler) of the carabiner. So, if the load falls directly on the coupler, its rupture is possible with a load of only 150-200 kg. The coupler easily opens with a simple movement of one finger, that facilitates the application on the routes of the Complex. Ergonomic shape of the carabiner fits perfectly into the hand, provides optimal work with the carabiner. Large opening (25 mm) improves fastening to ropes. The carabiner unlocks simply and easily, which facilitates frequent opening and closing. It is constantly necessary to attach both double lanyards to the rope along the route.

**2. Safe pulley is a technical device for working with a metal cable, which reduces the loss of force and energy on friction.**



The device is used as an independent movable block on a metal cable. Safe pulley has a guaranteed strength of at least 2200 kg. Double safe pulleys are guaranteed to withstand at least 500 kg per pulley. Double pulley with integrated carabiner for cable or rope crossing. Simple

hitching with one hand, reduced likelihood of a hitch error. Sequentially arranged pulleys guarantee stability of motion and reduce friction. Pressed ball bearings provide speed and efficiency regardless of user weight, ambient temperature or humidity. A wide opening carabiner allows you to easily insert a large diameter cable. The carabiner is unlocked with one finger, with a simple movement. The ergonomic shape of the carabiner is specially designed for comfortable grip. The coupler is easy to use and easy to close with one hand. The double pulley unlocks simply and easily, which facilitates frequent opening and closing.

### **Installation of the safe pulley before the descent (passage):**

- Install the safe pulley with a carabiner on the pass cable.
- Fasten both carabiners onto the pass cable of safe pulley.
- Attach the carabiners by hanging on the safe pulley with your weight, make sure it is correctly mounted on the cable. (The cable must be in the grooves of both pulleys). The load of the cable with your weight leads to the jump in order to avoid any risks of incorrect positioning of the safe pulley or carabiner while descent (passage). Please note that the carabiner hook must always be closed and locked by the coupler. Nothing should interfere with the operation of the carabiner. Any distortion or excessive pressure reduces its strength. Be careful to avoid getting your fingers or hair between the pulley and the cable. Attention! When the safe pulley is not used, hang it on the unloading loop of your harness. It is dangerous to leave the safe pulley hanging at the end of the lanyard (for example, it may get into the eyes).

### **3. Harness is a lightweight and compact special fall arrest system for sky-climbing, hiking on glaciers, multi-race.**

The mounting location is made of wear-resistant Dyneema material and is located above the belt. Leg straps are designed so as not to restrict the movements.



Easy to put on: leg straps have colour band coding for easy putting on the harness. DoubleBack buckles are easy to tighten in one movement and do not allow improper fastening. A high level of comfort due to wide leg straps and belt. Flexible loop for attaching equipment to the belt. Harness is adjustable to any size.



### **Putting on and adjusting the harness:**

Unravel your special fall arrest system before putting it on. Tighten the belt and secure the excess strap in the elastic clips. The safety loop should be centered. Tighten the leg straps and secure the excess strap in the elastic clips. The safety loop should be centered. Tighten the foot straps and secure the excess strap in the clips to prevent the buckles from loosening. The harness must be well fitted and correctly adjusted to eliminate the risk of personal injury in the event of a breakdown.

### **General rules for using a special fall arrest system:**

Re-fastening insurance is used for most of the proposed rope trails during which insurance is carried out by re-fastening carabiners from one safety cable to another. **The main safety rule on rope trails is that one of the carabiners must be always fastened with a safety cable or a metal ring with the corresponding mark!** This is your life insuring!

When climbing stairs on a ladder or rope ladder, immediately fasten the first carabiner, and then begin to climb. Going further, fasten the second carabiner, and only after that you can remove the first carabiner, move on and fasten it to the safety cable. Thus, securing the carabiners alternately along the safety cables, you move further along the trail. **You must not allow the carabiners to be loose and hanging on the ropes or hold in your hands - this is dangerous for your life!** The second most important rule is that only one visitor can be on a ladder, grid or playing distance. **On each rope trail on the trees, there are platforms on which no more than two Visitors can be at the same time.**

Before the start of the descent (passage), two **safety rules** must be remembered:

- when the safe pulley is attached to the safety cable, never put your hands on the safety cable, safe pulley, in the middle of the pulley ring or carabiners;
- you cannot start the descent until the previous person has come down to the end and has left the fenced area of the descent.

Before the descent, squat down, you will feel that the equipment is holding you, and push off smoothly the platform towards the descent (without any jerks). For your confidence, you can hold the carabiner ropes with both hands. You can also let go of your hands and descend in a free descent.

Trails No. 1, 10 and 11 end with wooden sloping shelves. When you are on the platform, it is necessary to remove the carabiners from the pulley one by one, securing them to the safety harness, then remove the pulley and fasten also to the safety harness. Then you need to go down from the old wooden platform and pass to the next trail according to the signs.

When descending into the grid (second, third, fourth, fifth, sixth and seventh trails) you need to grab hold of the grid with your hands. If you do not have time to grab the grid, then roll back along the cable to the bottom of its sag and stay hanging until the Instructor helps you get to the grid. **It is strictly forbidden** to try to grab the safety cable and move independently to the grid.

Then, having risen slightly up the grid, take off both carabiners one at a time, fasten them to the grid to go down to the ground (on white grids) or climb to the platform (on the green-intermediate grid). Having descended from the grid to the ground, remove both carabiners and fasten them to the safety belt and go beyond the fenced area and follow the following signs on the next trail.

Instructions for passing certain game distances indicated directly on the platforms before overcoming such ones.

### **Actions in extreme situations:**

An extreme situation means the failure and hang of a Visitor on the cable of the insurance line.

#### **Actions of a Visitor in extreme situations.**

In an extreme situation, a Visitor needs to listen carefully and follow all instructions of the instructor.

Upon incidence hanging on a cable of an insurance line, you must wait for the Instructor's instructions and try to return to the further passage of the route. If it is impossible to return to further passage of the route, it is necessary to wait until the Instructor takes measures to evacuate a Visitor from a distance.

**RULES FOR VISITING THE PLAYGROUND OF THE ROPE PARK IN THE TERRITORY OF THE "PARTYZANSKAYA SLAVA" REGIONAL LANDSCAPE PARK IN DARNYTSKYI DISTRICT OF KYIV CITY**

1. The playground is open from 10.00 every day. The schedule for ticket sale is available at the ticket desk and website of the Park ([www.seiklar.com.ua](http://www.seiklar.com.ua)).

Depending on the time of year and weather conditions, the opening hours of the playground can be changed.

2. The right to visit the playground is granted only after purchasing an entrance ticket. The entrance ticket is valid for one day and gives the right to one visit to the playground.

3. If the child leaves the playground, the ticket is canceled. Going outside the playground is allowed for adults, if necessary.

4. Children under the age of 7 years are allowed to the playground, accompanied by adults, who must monitor their children and are responsible for them.

5. During the passage (overcoming) of game obstacles, adults must help children overcome them.

Adults should really assess the physical capabilities, health status and ability of their children to pass (overcome) game obstacles.

6. When visiting the playground, visitors should not interfere with each other's use of games and/or overcoming obstacles.

A Visitor is aware that visiting the playground may cause damage to clothing and his items.

8. The Administration of the Complex is not responsible for the loss, damage of clothing and other things of a Visitor, including things left unattended.

9. While on the playground, it is prohibited to:

- make fire;
- bring alcoholic drinks with you and consume them. Discard rubbish, smoke (smoking is allowed in a designated place) and leave cigarette butts, bring and leave glass dishes;

- walk pets.
